

APPLICATION FOR MEMBERSHIP AND FOR ELECTRIC SERVICE

REA Energy Cooperative, Inc.

Indiana, Pennsylvania

The undersigned (hereinafter called the "Applicant") hereby applies for membership in and agrees to purchase electric service from REA Energy Cooperative, Inc. (hereinafter called the "Cooperative"), upon the following terms and conditions:

1. Applicant will pay to the Cooperative the sum of \$5 which, if this application is accepted by the Cooperative, will constitute the Applicant's membership fee. (The membership is non-refundable.)
2. The Applicant will purchase from the Cooperative all electric service used on the premises and will therefore pay monthly rates to be determined from time to time in accordance with the by-laws of the Cooperative; provided, however that the Cooperative may limit the amount of electric energy, service, or capacity to be furnished to any one member. The Applicant will pay a bill of at least the monthly service charge, regardless of the number of kilowatt hours consumed.
3. Applicant agrees to deposit with the Cooperative such consumer's deposit as is required by the Rules and Regulations and Policies of the cooperative; it is expressly understood that any portion of said deposit not applied to payment of bills due the Cooperative shall be refunded to Applicant upon termination of service.
4. The Applicant will comply with and be bound by the provisions of the articles of Incorporation and by-laws of the Cooperative, and such rules and regulations as may from time to time be adopted by the Cooperative.
5. The Applicant, by paying a membership fee and becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that under the law his/her Property is exempt from execution for any such debts or liabilities.
6. The Cooperative shall use reasonable diligence to provide a constant and uninterrupted flow of electric power and energy; but does not guarantee a continuous, uninterrupted flow of electric power and energy. In the event of an interruption in the supply of electric power and energy, the Cooperative shall not be liable for an incidental or consequential damages to the Applicant or any other person.
7. The Applicant and the Cooperative understand and agree that the purchase by the Applicant from the Cooperative, and the sale by the Cooperative to the Applicant of electric power and energy shall for all purposes be conclusively presumed to be a purchase and sale of services, and not of goods; and that the Cooperative makes no warranty of any kind regarding the quantity or quality of electric power and energy provided to Applicant.
8. By executing this application, Applicant or member by becoming a member and by dealing with the Cooperative, hereby grants the Cooperative such easements upon, over or under such member's lands for purposes of erecting, maintaining, repairing and servicing all such lines, facilities and equipment as may be necessary or convenient in order to provide electric and communications service to any members.
9. By executing this application, Applicant hereby authorizes the Cooperative to perform a credit investigation of Applicant, and to obtain any and all financial information regarding Applicant which may be reasonably necessary to perform said credit investigation, for which a copy of the Application shall be sufficient authority.
10. As used herein, the term "Applicant" shall include all persons executing this application so designated herein.
11. The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative, and the contract for electric service shall continue in force for one year from the date service is made available by the Cooperative to the Applicant, and thereafter until canceled by either party.
12. Applicant further evidences agreement to the following provision by the placement of Applicant's initials at the space provided.
13. The Applicant agrees that the Cooperative may, in its sole discretion, select any product, equipment, structure, facility or other good (collectively, the "Cooperative Equipment") for use in the operations of the Cooperative. Applicant further agrees that the Cooperative may, in its sole discretion, purchase, install, construct, inspect, monitor, operate, repair, maintain, remove, relocate, upgrade, or replace the Cooperative Equipment.

Applicant agrees that if Applicant fails to claim any cash retirement of capital credits, patronage distributions or other payment from the Cooperative within two (2) years after payment of the same has been made available to him/her by notice or by check mailed to him/her at his/her last address furnished by him/her to the Cooperative, such failure shall be and constitute and irrevocable assignment and gift by Applicant as a patron of the Cooperative. Failure to claim such payment shall include the failure by Applicant to cash any check mailed to him/her by the Cooperative at the last address furnished by him/her to the Cooperative.
