## **Playing it Safe Online**

IN TODAY'S WORLD, MOST OF us don't leave the front door to our home unlocked. We protect our homes, loved ones, and valuables from intruders with locks, alarms, and other security measures. Cybersecurity is no different. It's the practice of protecting valuable information, such as your identity, banking and health records, and other sensitive data, from digital attacks and theft.

October is Cybersecurity Awareness Month. The staff at REA Energy takes steps to ensure the personal information you share with us is protected, and we encourage you to do the same with information stored on your own personal devices.

According to the Cybersecurity and Infrastructure Agency, an arm of the U.S. Department of Homeland Security, these are the four best ways to keep you and your family safe online:

- 1. Implement multi-factor authentication (also known as two-step verification) on your accounts. This additional layer of protection makes it much harder for criminals to access your information. Even if a hacker obtains your password, they may be unable to access your accounts if multi-factor authentication is enabled.
- **2. Update your software.** This is one of the easiest ways to protect your personal data. When downloading a software update, make sure it's coming straight from the company that created it. Beware of fake pop-ups that request urgent downloads. Better yet, turn on automatic updates.
- **3. Think before you click.** Most successful cyberattacks start with phishing emails. Don't take the bait when cyber criminals go phishing. Avoid emails (or texts) that look too good to be true, are oddly urgent or poorly crafted, or include unusual requests.

**4.** Create strong passwords, using long, unique, and complex words or phrases. Consider using a password manager to save time, work across all devices, protect your identity and notify you of potential phishing websites.

#### For the young people in your household

Just as you would talk with your children about safety in the physical world, remember to discuss ways to stay safe online. Help them understand the public nature of the internet. Young people need to know early on that what is shared online stays online and is difficult (if not impossible) to take back.

Also, just as you would guard your money or valuables, children need to learn to guard their personal information, especially on social networks. As a parent or guardian, help kids learn about and use the privacy and security settings on social networks and gaming sites.

#### Keeping the electric grid and your data secure

REA Energy is doing its share on the cybersecurity front. Part of offering excellent service is keeping that service secure and reliable. For REA Energy, reliability means repairing wear and tear, upgrading our equipment to withstand storms and severe weather, and using technology and best practices to keep our system secure from cybersecurity issues.

While we can't stop a storm or predict every disruption, as a co-op, we do everything we can to keep the lights on and our members protected. Because if we all do our part, our interconnected world will be safer and more secure for everyone.

Cora does a great deal of decorating and propmaking, while Dan can be found maintaining the grounds.

"August is when we pick up the production to get the property ready for the start of the season," Amanda says. "It's all-hands-on-deck for all 40 of us on staff here."

With a dream to one day own an amusement park, the Ondos began their haunting journey in 2008 with a trick-or-treat event on their property. They decided to open the haunted trail in 2009 and officially changed its name to Scary Harry's in 2012. A year later, they moved the attraction to its current 10-acre property. In 2021, Scary Harry's was named the "Scariest Haunt" in Pennsylvania by The Scare Factor. The site competed against 69 other haunted attractions in the state.

Scare actors and staff must complete rigorous training each year to not only excel at scaring customers but to also keep those customers safe while on the property. Scary Harry's has more than \$100,000 in safety equipment on-site, and the staff must go through a minimum of eight hours of training each season. Scary Harry's and similar attractions are subject to state inspections and regulations to ensure customer and staff safety.

For many, visiting Scary Harry's Haunted Trails has become a Halloween tradition. The attraction welcomes 400 to 700 visitors a day during the spooky season. Whether you are a horror aficionado or someone seeking an unforgettable thrill, this haunted attraction promises to deliver an experience that will haunt your dreams long after the night is over.

Scary Harry's is a testament to the Ondos' artistry and passion for creating fear-inducing experiences. From its atmospheric setting to its meticulously crafted scares and immersive story-telling, every aspect of this attraction is designed to leave a lasting impression on those brave enough to venture into its depths. As Halloween approaches, dare to step into the darkness and discover why Scary Harry's is a destination that continues to captivate and terrify all who dare to visit.
